Pursuant to Article 54, paragraph 1, item 4 of the Law on Higher Education (“Official Gazette of the Republic of Srpska”, Nos. 67/20 and 107/24) and Article 41, paragraph 2, item 17 of the Statute of the University of East Sarajevo, in conjunction with Article 91, paragraph 9 of the Law on Higher Education, Article 6, paragraph 1 of the Rulebook on the Conditions for Election to Academic, Artistic-Teaching, Teaching and Associate Titles (“Official Gazette of the Republic of Srpska”, No. 69/23), and Article 170, paragraph 10 of the Statute of the University of East Sarajevo, the Senate of the University of East Sarajevo, at its 96th session held on 25 December 2025, hereby adopts the following:

RULEBOOK

ON AMENDMENTS TO THE RULEBOOK ON THE PROCEDURE FOR THE ELECTION OF ACADEMIC STAFF AT THE UNIVERSITY OF EAST SARAJEVO

Article 1

In the Rulebook on the Procedure for the Election of Academic Staff of the University of East Sarajevo, No. 01-C-302-1-LV/23 of 3 October 2023, after Article 2, a new Article 2a shall be added, reading as follows:

Article 2a

(1) The Annual Plan for Election to Academic Titles of teachers and associates, adopted by the Senate of the University in accordance with the procedure prescribed by the Law and the Statute of the University, shall provide for:

– the publication of a call for election, or for re-election of teachers and associates for whom, in the period from the adoption of the Annual Plan for Election to Academic Titles, and

no later than 1 February of the current year until the adoption of the annual plan for the following year, and no later than 31 January of the following year, it is necessary to initiate the procedure for election to title;

– the publication of a call for election to academic titles for new teachers and associates.

(2) Where there is a need for the employment of a new teacher due to the fact that the employment relationship of an employed teacher ceases upon reaching 68 years of age at the end of the current academic year, the call shall be published no later than 31 March of the current year.

(3) In all cases of proposed publication of a call for the election of new teachers and associates, the faculty/academy shall be obliged, with the proposal for publication of the call, to submit to the Senate of the University the data referred to in Article 2, paragraph 4 of this Rulebook.

(4) The Annual Plan for Election to Academic Titles may not be amended, except in the case where, during its implementation, the employment relationship of a teacher or associate has ceased, in which case the Senate of the University, upon a reasoned proposal of the faculty/academy, shall adopt a decision on the amendment to the Annual Plan for Election to Academic Titles.

(5) By way of exception to paragraph 4 of this Article, the Annual Plan for Election to Academic Titles may not be amended on the grounds of termination of the employment relationship of a teacher referred to in paragraph 2 of this Article of the Rulebook.

(6) Calls for election to academic titles of teachers and associates planned by the Annual Plan for Election to Academic Titles, or its amendments, may be published as of the date of adoption of the Annual Plan for Election to Academic Titles, or its amendments, provided that the faculty/academy council has submitted to the Senate of the University a decision establishing the proposal for publication of the call.

(7) In the case referred to in paragraph 6 of this Rulebook, the decision of the faculty/academy council shall contain a provision on its effect as of the date of adoption of the Annual Plan for Election to Academic Titles, or its amendments, by which the proposed publication of the call for election to academic title has been planned.

Article 3

This Rulebook shall enter into force on the eighth day from the date of its publication on the official website of the University.
